لجنة المطالبات للاجانب (اف سي سي) \ اى بي 5 | فحصت كل البيانات الخاصة بمطلبك و المستندات الخاصة بالمطلب و قامت بالتحقيق فى المطلب . و بأفضل المقاييس و التقديرات و بمراعاة المعلومات الموجودة فى المطلب و دراستها بدقة .  
بناء عليه اللجنة قررت التالى:

1. Facts: The claimant alleges that on an unknown date her house was bombed, her brother was killed and his car destroyed, and she lost all her hearing. The amount requested in damages is unspecified.
2. Opinion: The FCA permits compensation for damages caused by the negligent and wrongful acts of US forces. The claimant provided no evidence that the US committed a negligent or wrongful act. The incident was determined to be a combat action.
3. Authority: The Foreign Claims Act (10 U.S.C. § 2734) as implemented by AR 27-20, Chapter 10.
4. Action: The claim is therefore denied.
