TF 1-506 SAF Attack in SE Ar Ramadi OP Sky Train

IRON STORM

Operation IRAQI FREEDOM

At 170920cJAN06, TF 1-506 IN was attacked with SAF while conducting combat operations in Southern Ramadi. A/1-506 IN was attacked with SAF and the OSC declared a TIC.

DEALER (F-18) was supporting the maneuver unit and observed gunfire vicinity of the train station (b)(2)High

(b)(2)High

Gunshot 61 (Cobra gunship) also observed the SAF in the area near the train station. Red Currahee 6 authorized a (b)(2)High to suppress the enemy at the location of the SAF.

(b)(2)High

Gunshot 64 FAC A controlled the (b)(2)High using Type II.

Dealer 61 engaged the target with positive effects with the (b)(2)High entering the Northwest corner of the train station (4 EKIA).

The SAF stopped and the patrol continued operations in the city.

There were no injuries or damage to equipment.
