ON 22 MAY 05, I WAS THE PATROL LEADER OF THE D19 COMBAT PATROL. AT APPROX. 1745 HRS MY PATROL ENGAGED A VEHICLE THAT THEY BELIEVED TO BE A VBIED. MY PATROL FIRED ABOUT 20 ROUNDS OF 5.56MM IN TOTAL. FIRST THEY FIRED INTO THE MEDIAN, THEN IN FRONT OF THE VEHICLE AND FINALLY AT THE VEHICLE. WHEN THE VEHICLE DID NOT STOP, 4 ROUNDS OF .50 CALIBER WERE FIRED INTO THE VEHICLE. THE VEHICLE WAS FINALLY DISABLED AND CAME TO A STOP AT GRID (b)(2)High THE LOCAL NATIONAL DRIVER WAS SHOT ONCE IN THE CHEST AND WAS KILLED. THE DRIVER OF THE VEHICLE WAS (b)(6) AND HIS ADDRESS IS (b)(6) THE VEHICLE WAS REGISTERED TO THE VICTIM'S FATHER, (b)(6) THE VEHICLE WAS A (b)(6) BLACK, VOLKSWAGON GOLF, LICENSE PLATE (b)(6) ONE ROUND WENT THROUGH THE ENGINE BLOCK AND DISABLED THE VEHICLE. THE DECEASED BODY, ALL PERSONAL EFFECTS AND THE VEHICLE WERE GIVEN TO FAMILY MEMBERS EITHER AT THE SCENE OR AT THE HURRIYA IP STATION. A BDA WAS CONDUCTED OF THE AREA AND IT WAS DETERMINED THAT FOUR OTHER VEHICLES WERE DAMAGE, AND ONE HOT WATER HEATER. THE OWNERS OF THE VEHICLES AND THE STORE OWNER WERE ALL INFORMED ABOUT THE CLAIMS PROCESS AND TWO WERE ISSUED CLAIMS CARDS (DID NOT HAVE ENOUGH CLAIMS CARDS). 
