4. DESCRIPTION: On 02 January 2005, (b)(6) sister, a local national, was traveling to the College of Science for Girls. While near Coalition Forces, an IED exploded, and both the Iraqi Police and Coalition Forces engaged the AIF with gunfire. During the incident, his sister was struck by a stray bullet in the crossfire, and later died.
5. JUSTIFICATION: By making this condolence payment, MNF ensures the family and community recognize the MNFs' sympathy for the unfortunate occurrence. Support will positively influence both the community and local Iraqi leaders.
