I immediately call SPC Jenkins, one of the medics too, and run back to his location. I saw a old guy with a small boy in his arm asking for help. I immediately set up a cot on one of the houses, inside the courtyard. SPC (b)(3), (b)(6) went inside with me. SPC (b)(3), (b)(6) assist me at all time. The child was a 3 year old boy with two gunshot wounds on the left leg. One at the left thigh and one at the left heel. Also another gunshot wound that grazed his right thigh. I continue my assessment from head to toes, while at the same time start dressing up the wounds. I inform LT LAO the condition of the child and indicate him that the boy need to be taken to the TMC at FOB Liberty. LT LAO call it up higher. (b)(3), (b)(6) At that moment four individuals came to my location with the individual from the vehicle in subject. Asking to help him. I order SPC (b)(3), (b)(6) to check on the individual and he did a quick assessment and inform me that he was dead. At that moment and around 1840 we start moving back to the vehicles to take the child to the TMC with his grandfather. nothing follows

After the medics confirmed the KIA there was a call that a child was hit so SSG (b)(3), (b)(6) and (b)(3), (b)(6) and our two medics (SPC (b)(3), (b)(6) and SGT (b)(3), (b)(6) to want to treat the child still pulling security at my location. SSG (b)(3), (b)(6) with two Iraqi nationals went to the disabled burning victim to pull the casualty out and they took him to a different spot to further assess the casualty. Approximately 5 min after that my team and I was told to mount up into our vehicles with the child and return to Base. Nothing further.

On about 20070220 around 1755hr, my Platoon was conducting a dismantled patrol a Shulla munhalla (b)(2)High At vicinity (b)(2)High we were conducting a dismantled cordon security waiting for our vehicles to arrive to get in and leave the area. First Squad was leading the formation, 2nd Squad was in the rear of the formation. I was in the middle with SGT (b)(3), (b)(6) and the platoon leader 1LT (b)(3), (b)(6). I heard gun shots then ran for cover after taking cover I saw a car run into the fence on the other side of the road. About a couple min later I heard someone call for a medic. SGT (b)(3), (b)(6) ran over there to see what they wanted I was behind him. They told us to check the guy to see he is alive SGT (b)(3), (b)(6) lean in and check the guy pulse and said "he's Dead". So I check him and felt no pulse. I told SGT (b)(3), (b)(6) that I saw flames under the car and we should get away. at that time someone from the rear of the formation called for a medic and said there's a child hit SGT (b)(3)(b)(6) and me ran over there and saw a little boy in the arm of a local national. SGT (b)(3)(b)(6) set up a ccp in one of the court yard of the local national. when we assist the child we found a gun shot wound to the left leg and left ankle. The other leg had a graze wound on it. About a couple min later 4 local national brought the guy from the car over to the ccp ~~nothing follow~~ (b)(3)(b)(6)

 3), (b) on or about 2007 02 20, around 1800 hours, My Platoon was finishing a dismantled Patrol through Shuella's Muhalla we had stounded in the vicinity Grid (b)(2)High and set up our cordon (b)(2)High 1st Squad had the Front followed by Lt. (b)(2)High, SSGT (b)(2)High, 2 medics and Luther the interpreter. In the rear was 2nd Squad. Team leader Spc. (b)(3), (b)(6) was in charge of Bravo team and myself, PFC (b)(3), (b)(6), we had stopped traffic from approaching our cordon. There were 2 vehicles stopped in the oncoming lane. A Third vehicle approached the 2 stopped in the oncoming lane and then swerved around them into the other lane and sped up. Spc. (b)(3), (b)(6) gave hand and arm signals and was faced at the windshield. The car did not yield so Spc. (b)(3), (b)(6) fired a warning shot. Pfc. (b)(3), (b)(6) then fired a (b)(2)High into the radiator, it was clearly a tracer. The car sped up and swerved left (our right) to go around us. At this point in time I placed my sights onto the drivers torso and started to fire. I fired 12 rounds, 3 tracer and 9 Bells into the driver untill his vehicle stopped. Next we all took cover and picked up security thinking the vehicle was a VBIED. The Medics then ran up to the car and checked for a pulse on the driver; he was pronounced dead. At this point in time we heard someone yelling "there is a baby" and the medics ran to SSGT (b)(3), (b)(6). I then linked up with my A Team leader SGT (b)(3), (b)(6) and teammate Spc (b)(3), (b)(6) courtyard over. Next SSGT (b)(3), (b)(6) and 2 local nationals pulled the driver from the burning car dragging him to my team leader and me.

My platoon was just ending a dismounted patrol on mulhullah (b)(2)High in Shula. We were pulling a dismounted cordon at vicinity grid (b)(2)High waiting for our vehicles to come to our location and pick us up, to come back to base. The leading element of our formation was first squad followed by Lt. (b)(3), (b)(6), our two medics, SSG (b)(3), (b)(6), and our interpreter. Next was alpha team from second squad and bravo team (my team) was covering the rear with PFC (b)(3), (b)(6) preventing traffic from coming near our position. In the oncoming traffic lane there were two vehicles already stopped and cooperating with our commands not to proceed forward. All of a sudden the subject's vehicle drove around those 2 stopped vehicles into the wrong lane coming straight towards us. At that point I shined (b)(2)High on his windshield moving it around to signal him to stop. At the same time Spc. (b)(3), (b)(6) was showing the hand signal and yelling for him to stop. When he did not show any sign of doing so, Spc. (b)(3), (b)(6) fired a warning

My tracer round was clearly seen hitting his vehicle right through the radiator. The subject then accelerated towards us when me, Spc. (b)(3), (b)(6) and PFC (b)(3), (b)(6) commenced firing through the windshield to disable the driver. I fired 12 rounds out of my weapon until the vehicle came to a complete stop which finally ended up being inside our cordon. Seeing that the vehicle was on fire and thinking it was a VBIED and going to explode, the 3 of us ran into the nearest courtyard and took cover while awaiting further instruction. We remained there for approximately 20 minutes when I was told to mount up onto the Bradley & return to base. Nothin Follows




