suspect. I'm going to guess at about (b)(2)H rounds into the wall and then (b)(2)High more on the ground in front of the suspect. He clearly was not going to stop and had about (b)(2)High meters until he would be around a corner and we would not have been able to catch him. That's when Sgt (b)(3)(b)(6) said to take him down I believe (b)(2)High rounds total between Sgt (b)(3)(b)(6) and SPC (b)(3)(b)(6) were fired to take him down. The second he was down Sgt (b)(3)(b)(6) yelled (b)(2)High so we would look around. We looked where the suspect had been standing and started running from and saw the button of a mortar round. I yelled to Sgt (b)(3)(b)(6) that I could see the primer on the round and he confirmed and yelled for (b)(3)(b)(6) to move the vehicle down the road and clear of the round. I just looked over my statement and I realized I did not mention that I saw the suspect as he was coming around the corner, tucking something under his arm as if trying to hide it from us. We still don't know what it was or why he tried to hide it. Upon search we found nothing back to when we pulled forward. I grabbed my aid bag and awaited the chance to see if I could help the suspect. I could not go back the way we came because of the suspected round and the other two vehicles had not linked up yet. When the other two vehicles, 92 and 2, got there Sgt (b)(3)(b)(6) and I went through an open area around the round to link up with 92 and 2 because our comms went down as well as our power to the truck. When we got there the SCO and Sgt Major and XO were already there and then everyone went to the body to realize the suspect was already dead because one round struck him in the back of the head and exited the upper (b)(3)(b)(6) forehead. So there was nothing I could do for him.

On 11 Feb, 2006 I led a patrol, call sign (b)(2)High, for route Irish Clearance. At approximately (b)(2)High my patrol received a call from Rough Rider XRAY pertaining to two suspicious dirt mounds vicinity of the canal road grid (b)(2)High. After arriving within the area, Red 2 notices the road splits, I inform Red 3 which is SGT (b)(3)(b)(6), to push west and continue to scan for the dirt mounds. The Red 2 and Red 3 vehicles are approximately (b)(2)High apart as we both skirt around a building momentarily blocking our line of site. At this time my vehicle, Red 2 receives small arms contact from the east which is on the west side of Muhalla 885, I report contact. Immediately after which is approximately (b)(2)High seconds, Red 3 reports contact informing me that an individual has been shot. I report this to X-Ray and have them stand by as Red 3 develops the situation. I immediately put my vehicle, and my A92 in position to seal off the area. Red 3 informs Red 2 that an individual acting suspiciously peeks around the corner of a wall as his vehicle approaches then ducking back, Red 3 continues saying, as the individual

looks back around the corner, he appears to have a long object tucked under his arm. The individual was reported to have made a motion of tucking the long object under his arm and sprinting the opposite direction once the milky was upon him. Red 3 reports to have yelled stop in Arabic the first time, then firing several warning shots to stop the individual. Again Red 3 and his crew are yelling stop in Arabic and repeat warning shots. When the person did not stop, Red 3 actual which is SGT (b)(3)(b)(6), reported he fired (b)(2)Hig shots to stop, striking the individual and putting him on the ground. This was all done on the ground by SGT (b)(3)(b)(6) with an M4. SGT (b)(3)(b)(6) reported he could not send the medic due to suspected object could explode. I continued to report to XRAY when Rough Rider 6 arrives with PSD. As the situation develops as far as clearing the area, Rough Rider 6 calls XRAY to inform them there is no live UXO. Red 2 accompanies Rough Rider 6 and examines the body which has a single bullet hole to the head. Afterwards, we speak with a local family which heard the situation. After speaking with one of the males we learn that they heard clearly stop in Arabic several times from

ON 12 MARCH 06 AROUND (b)(2)High I WAS TRAVELING WITH MY SECTION ON (b)(2)High WHEN I HEARD A CONTACT REPORT COMING FROM APACHE RED 2. WE WERE IN THE AREA AND THE CLOSEST TO PATROL SO ROUCHRIDER 6 TOLD ME TO MOVE TO THE CONTACT AND ASSIST IN ANYWAY. MADE COORDINATION AND LINKED UP WITH APACHE RED 2 ON THE GROUND ABOUT 15 MIN LATER. UPON TALKING TO RED 2 HE TOLD US THE SITREP. AT THAT POINT RED 3 AND RED 2 AND RED 92 HAD A HASTY CORDON SET. RED 3 POINTED OUT WHERE THE PERSON WHO WAS SHOT WAS AND THAT THE MEDICS HAVE NOT LOOKED AT HIM YET. ROUCHRIDER 7 SAID IT WAS OK AND THE SUSPECTED IED WAS NOT AN IMMEDIATE THREAT, AND TO CHECK ON THE CASUALTY. MYSELF AND RED 3 WITH ELEMENTS OF THE PSD WALKED DOWN TO THE BODY AND VERIFIED HE WAS DEAD. I THEN ASKED RED 3 EXACTLY WHERE THE SUSPECTED IED WAS. WE GOT CLOSER TO THE POSSIBLE IED AND CONFIRMED IT TO BE DUNNAGE ONLY AND NOT AN IED. THE AREA WAS SECURE AND WE BEGAN TO RECOUNT THE CONTACT. RED 3 SAID THE KIA WAS CARRYING AND OBJECT AND WAS SPRINTING AWAY FROM THE TRUCK AND TOSSED SOMETHING OR STILL HAD SOMETHING UNDER NEATH HIS BODY. WE WALKED THE GROUND THAT THE ROUNDS WERE FIRED TO THE BODY. WE FOUND NOTHING SUSPICIOUS. RED 3, MYSELF, AND THEIR MEDIC THEN (b)(2)High WE CONTINUED TO SEARCH THE AREA FOR ABOUT 10 MORE MIN. HQ CALLED SCC TO PICK UP THE BODY SO WE WERE GOING TO WAIT TILL THEY ARRIVED TO RETRIEVE

THE BODY. AT THAT TIME MY WINGMAN (SABER 3) TOLD ME THERE WERE 3 MALES NEAR THE TRUCKS, INSIDE A FENCE. I TOLD HIM TO KEEP THEM THERE, AND I WANTED TO TALK TO THEM. MYSELF AND THE TEP (b)(6) WALKED OVER AND BEGAN A CONVERSATION. I KEPT MY QUESTION ABOUT THE AREA UNTIL I THOUGHT IT WOULD BE BEST TO SEE IF SOMEONE KNEW THE CASUALTY TO VERIFY HIM BEING AIF. I TOOK ONE INDIVIDUAL TO THE BODY WHERE HE SAID HE KNEW WHO HE WAS. HE SAID HIS NAME WAS (b)(6) BUT DIDNT KNOW HIS LAST NAME. I BEGAN ASKING QUESTIONS ABOUT THE CASUALTY TO DETERMINE WHAT HE WAS DOING HIDING FROM THE PATROL. THE INDIVIDUAL SAID THE MAN (b)(6)

(b)(6) AND OUT AFTER GURFEW, EVEN THOUGH THE NEIGHBORHOOD TOLD HIM TO STAY INSIDE. THE INDIVIDUAL SAID HE WAS SHOT NEXT TO HIS UNCLE'S HOUSE AND SHOWED ME IT WAS THE HOUSE IN FRONT OF THE BODY. WE WALKED BACK TO WHERE THE GROUP OF MEN WERE AND CONTINUED TALKING. HE TOLD ME THAT THE CASUALTY ALWAYS ACT SCARED AND SUSPICIOUS AROUND AMERICANS. THE MAN'S UNCLE CALLED AND THEY TALKED ABOUT THE EVENTS. I ASKED HIM IF HIS UNCLE SAW OR HEARD ANYTHING GOING ON PRIOR TO THE SHOOTING AND HE TOLD ME HIS UNCLE HEARD THE AMERICANS WARNING THE CASUALTY TO STOP, THEN HEARD ABOUT (2) ROUNDS FIRED. I GAVE HIM A CONTACT CARD AND HE SAID HE WOULD NOTIFY THE FAMILY. I ALSO TOOK DOWN HIS NAME AND GAVE IT TO SSG (b)(3)(b)(6) (REA 2) TO FOLLOW UP ON. TOLD HIM THANK YOU AND BRIEF RR 6 ON WHAT I FOUND OUT.
