SUBJECT: The Claim of (b)(6)

1. On 5 July 2008, (b)(6) submitted a claim at FOB Fallock, Iraq. Miss (b)(6) asserts that on 28 July 2007, US forces shot and killed her husband, (b)(6). I searched the CIDNE database and found that, on 28 July 2007, US forces were involved in two firefights with AIF in the vicinity. It is possible that Mr. (b)(6) was killed in the crossfire. Miss (b)(6) is claiming 5,978,499 Iraqi Dinar. (\$5,000)
2. I recommend denial of this claim under the provisions of the FCA. (b)(6) may have been killed by US forces engaged in combat, thus her claim is not compensable. The claim may be payable under CERP.
