1. The purpose of this memorandum is to request a Battle Damage Payment be made to (b)(6) (b)(6) in order to compensate him for the destruction of his taxi.

2. Description of the Event: At 010900JUL07, Bastard 26 reported an EOF while traveling West on route Deni West IVO (b)(2) High resulting in 2x LN KIA and 1x LN WIA (b)(6) a taxi driver, was transporting five local nationals in a red Audi sedan East bound on route Deni. The driver bypassed six local nation vehicles that were stopped on the South side of the road and proceeded toward the Bastard 26 patrol. SPC (b)(6) b the gunner of the lead vehicle utilized (b)(2)High signals to alert the civilian driver and (b)(2)High fired (b)(2)High with no effects. At (b)(2)High the gunner fired a warning burst of 3x rounds of (b)(2)High to the north side of the road. The vehicle continued and showed no sign of slowing or changing course. At 2 meters, the gunner fired 10x rounds of (b)(2)High to disable the vehicle resulting in 2x LN KIA and 1x LN WIA. B26 cleared the vehicle with NSTRK and began administering aid to the casualties. The vehicle subsequently caught fire and quickly became engulfed in flames. The casualties were transported to PB Baker. At 0957, Bad Blood 75 departed PB Baker with (b)(6) (b)(6) suffering from a GSW to the abdomen and fragmentation wounds to the legs. The casualty was MEDEVAC to FOB Warrior for further treatment
