SUBJECT: Fiscal Review of CERP Condolence Payment – 08-4-2-0519

1. Conclusion. I have conducted a legal review of the request to pay a CERP condolence payment to (b)(6) for the death of his family members. This request originally processed as a claim under the Foreign Claims Act (FCA); however, the U.S. Army denied the FCA claim because the damage resulted from a combat operation.

2. Condolence payments for Iraqi citizens are authorized for property damage caused by Coalition, US, and Iraqi Security Forces. Based on the documents submitted, including a claims card, there is some evidence suggesting US involvement in this incident. As such, you could make a finding that the property damage was caused by US Forces, and make a condolence payment to this individual within your discretion.
