I THEN INFORMED SSG (b)(3), (b)(6) (S)(L) WHAT WAS GOING ON. SSG (b)(3), (b)(6) (S)(L) THEN CAME UP TO MY POSITION TO ASSESS THE SITUATION. I THEN TOOK MY POSITION BEHIND THE (b)(2)High THE TRUCK PASSED THE ROCKS THAT WERE ACROSS THE ROAD AND PROCEEDED TO PASS (b)(2)High AT THIS TIME SSG (b)(3), (b)(6) (S)(L) FIRED A WARNING SHOT IN FRONT OF THE TRUCK WITH A TRACER ROUND FROM THE (b)(2)High THE TRUCK CONTINUED FORWARD WITH OUT ANY SIGN OF STOPPING. WHEN IT REACHED THE (b)(2)High I FIRED A 4-6 ROUND BURST FROM THE (b)(2)High AT THE FRONT OF THE TRUCK TRYING TO WARN AND (b)(2)High THE ENGINE OF THE TRUCK.
