<b>DESCRIBE WHAT HAPPENED (STEP BY STEP - use additional pages if necessary)</b>			
<p>OP Post #09 is an elevated Wooden Observation tower, Roster # 038 (b)(6) and Roster #134 (b)(6) were manning the tower at the time of the incident. At approx 1100 hrs Gideon reported via radio that they were "taking fire" at their location. (b)(6) reported approx 5 rounds of unknown caliber had been fired at their location from a Black type sedan which was on a by-pass road approx 500 meters out. After firing rounds at their location, the black sedan speeded away towards the west, the same way it had come. Gideon reported 3-4 individuals in the sedan, unknown any further due to the distance. Gideon reported they did not return fire due to the subjects being outside their designated field of fire. The incident was reported to the TOC, 1 Panther 71, SSM (b)(6) and XO (b)(6). No injuries were reported from SOC employees. 1 Panther 71 reported that the suspect vehicle was tracked by military observation post, identified and engaged with 2 KIA's and 2 with unknown injuries who wandered into the desert.</p>

*On or about 11 October 2007 1115 hrs, I was in the 1505<sup>th</sup> PIR TAC when OP 29 reported receiving small arms fire from a (b)(6) vehicle with at least 2 people in the vehicle. The raid aircraft quickly acquired the vehicle traveling at a high rate of speed. Fixed Wing was called and acquired the vehicle. The fixed wing was given permission to engage the vehicle. Further to my recent telephone conversation with your secretary, I set out herein the facts concerning the horrific American military attack upon my family in Northern Iraq.

On 18<sup>th</sup> of October 2007 at about 11:00am local Baghdad time, six members of my family comprising of:

- Were all returning home after my niece (b)(6) had undergone a successful operation at (b)(6) general hospital in (b)(6). Whilst lawfully travelling on the public highway in their family car on route to their home-town of (b)(6) of the country, they were near a town called (b)(6) when they were followed by an American Helicopter. The car was not in a battle zone and without warning the said helicopter fired three missiles in the direction of the car which exploded nearby, where they were forced to stop and flee the vehicle.

Thereafter, they frantically began waving to the pilot of the helicopter whom they could clearly see with white clothing indicating that they were unarmed civilian men women and children. The helicopter soon disappeared from view and they then sought refuge some distance from the car.

Approximately 20 minutes later when it seemed that the danger was over, they assembled and made their way back to the car. However, on reaching the vehicle the helicopter returned back and shot them with a missile struck killing my two brothers:

It is believed as this was on instructions of the American forces who attended the scene shortly after the attack took place.

The above facts disclose that an unjustifiable act of aggression was committed by American military forces against helpless civilian victims, contrary to the Laws of War and the Geneva Conventions. My family was not a belligerent enemy armed force and neither was the force used against them proportionate, since there was no military necessity to use any force in this case. They were simply travelling home in a civilian car on a highway used by other members of the public.

Those responsible for the cold blooded murder of an innocent family and the burying of the truth must not be allowed to get away with such criminal conduct. Civilised nations have developed laws to protect humanity and the requirements of the public conscience regardless of battlefield justifications.

I am writing to express my extreme anger and outrage at the recent massacre of members of my family. In one cowardly act committed by the Americans, I lost two of my uncles, my aunt and her baby.

On 18<sup>th</sup> of October 2007, I and two of my uncles, (b)(6)

We were making good progress and left the town of (b)(6) behind us at around 11:00 o'clock. Shortly afterwards though, our peaceful journey was shockingly disrupted by what appeared to be warning shots fired by an American helicopter around our car. In response and terrified, we pulled over to one side of the road and left the car in a hurry. In an effort to signal to the helicopter crew that we were unarmed civilians, we waved white cloths as we walked away from the car. We breathed a sigh of relief when the helicopter appeared to leave the scene. We waited for about 20 minutes after the helicopter disappeared from view and could no longer be heard before we made our way back to the car.

My two uncles led us back to the car, followed by my aunt and her baby who was followed by my young cousin and me. As my two uncles were about to open the car doors, the helicopter suddenly reappeared and fired a missile causing a huge explosion which ripped apart the group and threw us away from the car.

Upon regaining consciousness and feeling dazed and terrified, I could see that I had lost parts of my left hand and was covered with blood everywhere. I ran around to check on the others, only to discover to my horror that the explosion has killed my two uncles,

My family was not a belligerent enemy armed force and neither was the force used against them proportionate, since there was no military necessity to use any force in this case. They were simply travelling home in a civilian car on a highway used by other members of the public

My family and I wept for days and are grief stricken. Our grief is compounded by the worry and concerns about the well being of the children left behind by my two uncles.

Following me your telephone conversation Last night, I would like to thank you in advanced for your help in taking this case forward. As per your request I have attached the statement of, Mr (b)(3)(b)(6) a member of the American Military Police who is the first to arrive to the scene. From his statement, he has confirmed that it was a civilian family, wearing traditional Iraqi clothing travelling in a private civilian car on a public road that were attacked. He also confirmed that no explosives or weapons were found in the car or on any of the victims. As you can see from the statement, my family members were attacked by an American powerful airburst from the air about 100 meters away from their car while they traing to seek refuge allowing the crow to see them clearly.

Not only did this atrocity occur, but also neither American nor Iraqi authorities were on the scene until at least an hour after this incident had occurred, by which even if any of them were still alive, not a single one of them would survive.
