THE LN APPROACHED THE CF UNIT IN A DUMP TRUCK AND IGNORED A RANGE OF EOF MEASURES BEFORE THE CF UNIT (2-82 BCT) ENGA (b)(2)High CAB OF THE TRUCK WITH SEVERAL 6-9 ROUND BURSTS OF (b)(2)High MACHINE GUN FIRE. THE TRUCK CRASHED INTO BARRIERS. THE DRIVER WAS OBSERVED SLUMPED IN THE CAB FROM AN APPARENT HEAD WOUND.
