(c) Brief Description: EOF with Death of LN. . 2/B/1-17 REPORTED ENGAGING A VEHICLE CLOSING ON A DISMOUNTED PATROL IN THE RUSSAFA NEIGHBORHOOD (MB 45219 91044). 2/B WAS CONDUCTING A FLASH TCZ ON AN UN-NAMED ROAD INTERSECTING WITH A TRAFFIC CIRCLE. STRYKERS WERE USED TO CORDON OFF THE AREA FOCUSING ON THE ROAD TO THE NORTH WEST PORTION OF THE TRAFFIC CIRCLE. THE AIR GUARD ON THE B42 VEHICLE WAS OVERWATCHING THE STOPPED TRAFFIC WHEN A CAR (WHITE 4 DOOR), WITH 1 X LN MALE, DROVE HIS CAR AROUND THE STOPPED TRAFFIC TOWARD THE DISMOUNTED PATROL. THE STRYKER AIR GUARD USED EOF PROCEDURES CONSISTING OF HAND AND ARM SIGNALS, AUDIBLE VOICE AND 1 X WARNING SHOT; THE CAR CONTINUED ON ITS COURSE WITH NO REACTION TO THE WARNINGS. THE DISMOUNTED 2/B PERSONNEL WITNESSED THESE EVENTS (HEARD THE 1 X WARNING SHOT) AND STARTED THE EOF PROCEDURES AGAIN (HAND AND ARM, AUDIBLE VOICE AND 2 X WARNING SHOTS). THE VEHICLE CONTINUED WITH NO REGARD TO THE DISMOUNTED PERSONNEL WARNINGS. 2/B (DISMOUNTED AND MOUNTED) ENGAGED THE VEHICLE WITH DISABLING SHOTS AND LETHAL SHOTS FOLLOWED (ALL 5.56 RND). DISMOUNTED SOLDIERS MADE EYE CONTACT WITH THE LN INDIVIDUAL WHILE GIVING EOF WARNINGS

AND DURING DISABLING / LETHAL SHOTS. 1 X LN MALE WAS KIA FROM THE ENGAGEMENT. 2/B SEARCHED THE VEHICLE AND CONDUCTED SSE WITH NEGATIVE RESULTS. 2/B LOCATED THE LN's CELL PHONE, BUT IT WAS INOPERABLE. THE SIM CHIP WAS EXTRACTED IOT GAIN INFORMATION TO CONTACT THE FAMILY. THE NAME OF THE LN: NEMH EDREES SIMAN; DOB 1951. FOLLOW UP WITH THE FAMILY WILL BE CONDUCTED.
