

I investigated the 28 June shooting on 29 June. I briefly attended the wake for one of the KIAs and facilitated delivering his body to the mosque for washing and delivery to his final resting place. I know (in a limited fashion from previous conversations) the family of the KIA and believed them when they said that their son was digging, but it was not to put in an IED. I told them not to dig in the street after dark because they will be shot for being a deep buried IED emplacer. They said they knew that already. They claim their son was digging on the side of the road as to improve his garden. I believe them; regardless, the guy is dead and the money to help the surviving family may endear them to providing tips and information in the future. nothing follows,



On the night of 28 June 2007, our convoy was doing a patrol in (b)(2)High. Our convoy had stopped on (b)(2)High About 10 minutes after we had stopped the gunner in my truck PFC (b)(3),(b)(6) said he seen 3 males digging in the side of the road about (b)(2)High Meters to the front of our truck. I looked and saw three I.V. one was digging on the side of the road while two others were keeping a lookout. One male continued to walk back and forth across the road. We called it up to our patrol leader LT (b)(3),(b)(6) He took a look and told PFC (b)(3),(b)(6) to engage. After we engaged we maneuvered to their position. Once we arrived we were waved down by a family who brought out a injured AIF. Our medic then treated him. We then took him to the CSH in the green zone. When we engaged the AIF we were located at grid (b)(2)High and the AIF were at (b)(2)High This all happened at 2245 hours.
