



- (c) Brief Description: LOAC Violation: Allegedly US Soldiers killed 2 men and wounded another in Tarmiya on 17 Feb 05. The file included witness statements, a Kadamiya judge's order for autopsy, etc. Most of the evidence is hearsay and conflicting about method and place of killing. IO received many translated documents on 1 AUG.

- (c) Brief Description: LOAC violation: Patrol in Yusifiyah allegedly raped and murdered LN girl. CID investigating; GCMCA to 101st. AR 15-6 IO appointed 5 July to look into general command and control of 1-502nd, 2BCT, 101st ABN.

4BCT, 101st AA

- (a) Date of Incident: 10 July 2006
- (b) Unit: HHB, 4-320 FA
- (c) Brief Descr [redacted] Death of Local National: Initial report of shot to chest not accurate, but rather shot to the leg. SPC (b)(3)(b)(6) shot and killed LN during cordon and search ops in Zafrinya. HHB had mission to search for young girl who was alle [redacted] ducted [redacted] aped by L [redacted] hree 4-man assault teams searching. One team: SGT (b)(3)(b)(6) (TL), SGT (b)(3)(b)(6), SPC (b)(3)(b)(6), d SPC (b)(3)(b)(6). Team entered billiard room and directed LNs out; one LN attempted to wrestle SP (b)(3)(b)(6) weapon away from him (all 4 sworn statements consistent on th [redacted] d, then attempted to flee aro [redacted] eam chased, shouting "stop" in Arabic, no avail. SGT (b)(3)(b)(6) fired war [redacted] ot, no avail. SGT (b)(3)(b)(6) fired non-lethal into midsection, turned, groaned, contin [redacted] ing. SGT (b)(3)(b)(6) states that LN tu [redacted] ain and "had something in his hand but I didn't know what." SPC (b)(3)(b)(6) the "disabling" round into leg (mentions nothing about object in LN hand). All 4 SMs believed LN wanted to gain control of weapon. Medic on scene in a minute, but LN died soon after. IO found no negligence; EOF and ROE followed, rec's refresher training and no adverse action. Bde Cdr concurs.
