Soldiers gave verbal warnings, fired warning shots and then engaged on the vehicle. The driver, a LN named Edan Jassim, was KIA. The passenger sustained minor injuries and was released.

(c) Brief Description of Incident: Conducted EOF on a (b)(6) Element was conducting a dismounted patrol at the time on alley ways in the neighborhood. At approximately (b)(2)HM, element tried yelling at the LN to get hi top. At (b)(2)HM, element conti yelling d used hand and arm signals. At (b)(2)HM, elem fired several warning shots. At (b)(2)HM, disabling shots were fired into ood of the car. The vehicle did not deviate from its course. Element then switched to lethal fires and killed 1xLN. Other contributing factors to the EOF, vehicle was a BOLO vehicle with only 1 x Male LN dressed all in white. At no time did the vehicle slow down until lethal fires were taken. There were also no other LNs in the vicinity and the shops were closed in the area in an otherwise fairly busy neighborhood.




