D31 or D34 were set up in an OP at 0718. I was the driver of D31. A white Toyota passed us, then turned around and passed us again then which we started to move to pull the truck over to search it. By the time we got to him the truck was pulled over with the hood up. D34's IC SFC (b)(3), (b)(6) told him to move away from the vehicle. The man did not, and yelled something back and got back in the truck and took off D34's crew (b)(2)High but he proceeded down the road they then opened up on the cab of the truck hitting the driver. When the truck stopped we pulled up and D31 Loader PFC (b)(3), (b)(6) and D34 Loader PFC (b)(3), (b)(6) dismounted and pulled the guy out of the truck and started preping for medical attention. (b)(3), (b)(6) showed up with the Humvee crew and started first aid, after about 5 or 10 mins the DOC pronounced the guy died, so they then searched the truck, and the IA showed up and loaded the body up with all his personal items. Then we proceeded to the start of the incident and searched the ground for anything.
