(a) Date of Incident: 24 June 2006

(b) Unit: A Co., 14th EN BN

(c) Brief Description: Unit conducted an EOF while executing a route clearance patrol on MSR Tampa. A LN drove his vehicle at a high rate of speed towards the [redacted] of the patrol as they were traveling north on MSR [redacted] in TAI Alaska. PFC [redacted] the gunner for the last vehicle in the order of [redacted], used hand and arms in an attempt to get the driver to slow down at [redacted] High. When the driver did not respond, PFC [redacted] fired a warning shot at [redacted] High. LN sped up at which time PFC [redacted] felt that the LN showed the hostile act of using his vehicle as a platform for a SVBIED. PFC [redacted] fired disabling shots at the vehicle, killing the driver at [redacted] High.

- (c) Brief Description: An EOF was conducted by 1-17IN when a vehicle approached the unit at a high rate of speed while the unit was securing a PIED site in the Nineveh province in Mosul. The vehicle exploded when disabling rounds were fired. The driver was killed in the explosion. 709 rpts 1 LN was killed while driving a taxi in the area when the vehicle exploded. Shrapnel from the vehicle that exploded penetrated through the taxi and struck the LN in the abdomen.
