1. WHAT IS YOUR DUTY POSITION?
MY MOS IS 92G(COOK).

2. HOW LONG HAVE YOU BEEN IN THE ARMY? HOW LONG IN COUNTRY FOR THIS DEPLOYMENT?
I HAVE BEEN IN THE ARMY 6 YEARS AND HAVE BEEN IN COUNTRY 5 MONTHS

3. DO YOU HAVE PRIOR COMBAT DEPLOYMENTS? IF SO, WHEN AND WHERE?
YES I DEPLOYED TO IRAQ WITH THE SQUADRON LAST TIME IN OCT 2006 TO JAN 2008.

4. WHERE WAS YOUR BATTLE POSITION ON 3 OCTOBER 2009 AT COP KEATING?
MY BATTLE POSITION WAS TO REPORT TO TOC AND WAIT TO SEE WHO NEEDED HELP ON BATTLE FIELD. I GET ORDERS TO RUN AMMO TO DIFFERENT LOCATIONS.

5. WHAT WERE YOUR ACTIONS DURING THE FIGHT? I RAN WITH A FEW MORE OTHER GUYS AND HELP BRING ROUNDS TO THE TRUCK UP BY THE DFAC (B-11) AND HELP RETURN FIRE ON THOSE MOVING ON BATTLE FIELD. I HELPED RETURN FIRE BETWEEN THE GENERATOR AND THE MOSQUE (B-13), FOR ABOUT 30 MUNITES. AFTER HELPING RETURN FIRE, I RAN BACK TO THE TOC (B-3). I STAYED THERE UNTIL I DECIDED THAT WE NEEDED MORE AMMO FOR THE DIFFERENT BATTLE POSITIONS. I RAN TO MAKE TWO AMMO RE-SUPPLY. THE FIRST AMMO RE-SUPPLY WAS THE .50 CAL LOCATED SOUTH OF THE B-11. AFTER I MADE THE RE-SUPPLY, I HELPED THE SOLDIERS BY B-13, SPC (b)(3), (b)(6) SP(b)(3), (b)(6) AND SPC (b)(3), (b)(6). THEY WERE AT THE SAME LOCATION WHERE I WAS BEFORE. THEN I RAN BACK TO THE B-3 TO GET THE NEXT ORDER. THE SECOND RE-SUPPLY ORDER WAS FOR ANYONE ELSE WHO NEEDED AMMO RE-SUPPLY. AFTER MAKING THE SECOND AMMO RE-SUPPLY, I WAS RUNNING BACK TO B-3 WHEN I WAS HIT BY SHARPNEL ON MY LEFT CALT BY THE REAR B-3 ENTRY POINT. MY INTENT WAS TO RETURN TO B-3, BUT I DECIDED TO GO TO MY LIVING QUARTERS (B-7) TO GET OUT OF THE IMMEDIATE DANGER. UNTIL THE OMLT LATVIAN (1SG (b)(6) & CPL (b)(6) CAME TO GET THEIR WEAPON SYSTEM AND PROVIDED COVER FOR ME TO GET TO B-3. AND I REMAINED IN B-3 UNTIL THE END OF THE ENGAGEMENT. I WAS MEDEVAC TO BOSTICK AID STATION, I WAS NOT LITTER URGENT.
