2. HOW LONG HAVE YOU BEEN IN THE ARMY? HOW LONG IN COUNTRY FOR THIS DEPLOYMENT? I have been in the Army for 9 years.
3. DO YOU HAVE PRIOR COMBAT DEPLOYMENTS? IF SO, WHEN AND WHERE? I have one deployment to Iraq, from 2003 thru 2004.
4. HAVE YOU SPENT ANYTIME AT COP KEATING? IS SO, WHEN WERE YOU THERE? No. never.
5. WHEN DID YOU ARRIVE AT OP FRITCHE? HOW LONG WERE YOU THERE AND WHEN DID YOU LEAVE? I arrived at O.P Fritsche in the beginning of August, I was there for a little over 2 months and left on October 8, 2009 when it was finally closed.
6. BRIEFLY DESCRIBE YOUR ACTIONS ON 3 OCT 09, DURING THE ATTACK ON OP FRITCHE. On October 3, I was awoken by an explosion that hit the barracks and was caused by an indirect round.
7. DID YOU PROVIDE ANY FIRE SUPPORT OR QRF RESPONSE TO COP KEATING ON 3 OCT 09? No, I did not.
8. DID YOU EXPERIANCE ANY WEAPONS MALFUNCTIONS DURING THE ATTACK? No, but with the amount of ammo I fired, the only complication I had was when the weapon itself got so hot that it could not fire any more rounds.
