9. I, **(b)(3), (b)(6)**, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

on the morning of Oct 3, 2009 at around 06:00 I was awoken after a RPG impacted the COP. I put my gear on and awaited orders on what to do. SFC **(b)(3), (b)(6)** told us to start running ammo to the trucks I followed the guys out the door headed to the ASP. Once we got to the asp myself and SPC **(b)(3), (b)(6)** went into the middle one where Sgt. **(b)(3), (b)(6)** stood guard outside for us when a RPG hit Blowing Sgt **(b)(3), (b)(6)** into the door we then fell back to the ASG shack were I saw blood on Sgt **(b)(3), (b)(6)** gear I grabbed his arm and started looking to see where the blood was coming from. I found a few spots on his arm and one that still had some metal in it and pulled it out we then fell back to the barracks and awaited orders **(b)(3), (b)(6)** again. Once again SFC **(b)(3), (b)(6)** told us to run more ammo and as we started heading out the door SPC **(b)(3), (b)(6)** came crawling back inside saying that he was hit and that scusa was dead as Sgt **(b)(3), (b)(6)** and Sgt **(b)(3), (b)(6)** made there move out to get him I went out to help give them some cover, as we made it back **(b)(3), (b)(6)** in the barracks myself, Sgt **(b)(3), (b)(6)** and Sgt **(b)(3), (b)(6)** went back out to the ASP to get more ammo. After getting the ammo I made my way to the Cafe were some guys from Red had pushed too. I then pushed back up with guys from Red to take back the ECP as we made are push we held up

at the ASP, Ssg (b)(3), (b)(6) told me that as myself, Sgt (b)(3), (b)(6) and the rest of the guy from (b)(2) High what he wanted us to do. I got eyes on three AAF's moving on the COP I then opened fire with the SAW, as (b)(3), (b)(6) shot 203's in the area where we saw them. Soon after myself, Sgt (b)(3), (b)(6) Ssg (b)(3), (b)(6) and (b)(3), (b)(6) started are push to the ECP. RAZ 203ed the door and we pushed in I did a burst in the ECP and pushed in, taking back the ECP still taking heavy fire and RPG's we held the ECP. We then got word that are team was goin to make a push out to get the guys that had fallen. Sgt (b)(3), (b)(6) and (b)(3), (b)(6) ran out to get griffin and I layed down cover fire as they made there move. We then went out with myself, Sgt (b)(3), (b)(6) Ssg (b)(3), (b)(6) Ssg (b)(3), (b)(6), Sgt (b)(3), (b)(6) and (b)(3), (b)(6) to get the rest of are guys, moving up in two man teams we made are way to the shit house I posted with the SAW to cover the switchbacks as the rest of the team moved up to search. They found Sgt Martin and I moved up to the side of the shit house, Then myself and Sp (b)(3), (b)(6) moved up to cover so they could recover Sgt Gallegos once they did Sgt (b)(3), (b)(6) and I pushed back with the rest of the team makin are way back to the ECP holding there till the ORF got there.
