I, (b)(3), (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
I was on ECP guard when a TERP came and said that the Taliban was in Ramule then ran to the talk to tell them. I then went to the piss tubes then saw the outgoing SOG and told him what TERP had said. I then went back to the barracks and laid down to sleep. Then the first rounds hit. I threw on my gear and grabbed my MK46 and went to the front entrance to go to the ECP as support. I couldn't go out the front way due to all the rounds hitting the stairs, roof, and ground in front of the door. I turned around and went to the back door. There I met with SGT. KIRK (b)(3), (b)(6) we then bound to the ECP giving each other covering fire. Once we got to the ECP we went to the double doors. PFC (b)(3), (b)(6) couldn't get back up in the turret due to sniper fire and indirect fire. SGT. KIRK stepped out the double doors and fired his 203 then stepped back in. He told me to cover him while he fired a AT4 at the putting green. We then stepped out the doors together right then an RPG hit the side of the building right next to the doors. IT BLEW me into the building and SGT. KIRK out side. He was on the ground and bleeding from the face. me and (b)(3), (b)(6) grabbed SGT. KIRK by his vest and drug him inside the building. I began evaluating him when (b)(3), (b)(6) grabbed SGT. KIRK's radio and called for a medic. SSG (b)(3), (b)(6) showed up and asked for a stretcher me and (b)(3), (b)(6) took off to look for one once I got to the barracks building SSG (b)(3), (b)(6) gave me a whole bunch of 7.62 linked ammo and said SSG (b)(3), (b)(6) needed it behind the generators.

I Then made my way to The Generators where I found SSG (b)(3), (b)(6) firing a MK48 at the Putting Green and Switch Backs. He soon ran out of ammo while He was reloading I fired my MK48 to cover him. once He was up I reloaded my MK48. Just then an RPG hit just to the right of us and knocked us down. We got up and SSG (b)(3), (b)(6) said to hold this spot and went to go get more people. and ammo not long after another RPG hit the generator, I then got in the trench right behind the generator and sniper rounds were hitting the building right behind me. soon (b)(3), (b)(6) showed up. I told them to get down in the ditch with me. Just then and RPG hit the building behind us breaking all the windows out putting broken glass all over us. soon SSG (b)(3), (b)(6) jumped in the ditch with us and was firing 203 towards the North Face. He then saw an enemy person over by the Board walk and called it in as "charlie is in the wire" I then saw 2 enemy people near the shower trailer and A+A mortar pit. I then fired 50 rounds out of the MK48 at them. we were then taking more sniper fire. me, (b)(3), (b)(6) and SSG (b)(3), (b)(6) took the end of the trench and made a mad dash into our barracks one at a time covering each other with fire. once in the barracks we took up positions inside the buildings. they then decided to take back the cop. I passed my MK48 to (b)(3), (b)(6) and grabbed my M-4. I then went to AG for SSG (b)(3), (b)(6) and the aid station. we then pushed up to the Hesco barrier next to inbetween the Chow Hall and the Tool Shed. it was me, (b)(3), (b)(6) and Sgt. (b)(3), (b)(6) from there we could cover the diving board and switch backs we stayed there all night untill the fire spread and made it unsafe for us to stay there. By then chosen company had come and picked up that sector of fire and we collapsed. Thus ending my part in it.
