4. WHERE WAS YOUR BATTLE POSITION ON 3 OCTOBER 2009 AT COP KEATING?
I WAS SLEEPING WHEN IT FIRST TOOK PLACE IN BLDG #5 AND MOVED TO BUILDING #1. I MADE A FEW TRIPS BACK AND FORTH AND FOUGHT SEVERL ENEMY FIGHTERS FROM THE EAST DOOR AT #5, MOVED BACK TO #1 AND ENGAGED SEVERAL MORE ENEMY FIGHTERS FROM THERE. I THEN CLEARED ALL OF THE EAST SIDE AT THE ANA SIDE OF THE COP INCLUDING BUILDING 5, 8. MOST OF THE ANA SIDE WAS ON FIRE AND COULDN'T PUSH THROUGH, BUT FOUND SEVERAL AAF AND ENGAGED THEM FROM DOORS OF 5 AND 8. I THEN MOVED TO #4 AND WAS STILL COVERING THE EAST. THEN WITH 4 SOLDIERS (PFC (b)(3), (b)(6) PFC (b)(3), (b)(6) SPC (b)(3), (b)(6) PFC (b)(3), (b)(6) MOVED TO THE SOUTH WITH 2 M240Bs AND SET UP A SMALL FIGHTING POSITION WITH C WIRE AND A HESCO AND COVERD THE SWITCH BACKS AND SAW 2 TO 3 AAF ON THE SOUTH SIDE OF 18. WE ENGAGED THEM AND A COUPLE HOURS LATER QRF SHOWED UP.

IT WAS SURROUNDED BY HIGH GROUND ON EVERY SIDE WITH BLIND CORNERS, ALL OF THE FIGHTING POSITIONS HAD RECOMMENDATIONS TO IMPROVE BUT NOTHING WAS DONE. TOO MUCH TRUST IN ON THE ANA SIDE TO COVER THE EAST OF THE COP

7. WHAT WAS FIRST ENEMY ACTION YOU SAW? WHERE WERE YOU, AND WHERE DID YOU MOVE?

I FIRST SAW THE ENEMY BY THE THE MAINTENANCE BUILDING, I WAS AT THE ASP AND STAYED UNTIL I WAS CALLED TO CLEAR THE EAST
