9. I, (b)(3), (b)(6) WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
on the day of 03 Oct 09 I arrived at OP Fritche at around 1300 via Blackhawk along with CPT (b)(3), (b)(6) LT (b)(3), (b)(6) and SSG (b)(3), (b)(6) in response to the attack on COP Keating. Arriving on separate Blackhawks the 10th Mountain QRF call signed (b)(2)High CPT (b)(3), (b)(6) and LT (b)(3), (b)(6) headed to the TOC for a situation update and I took position along the perimeter with a 240B. After about an hour a patrol consisting of: (b)(2)High CPT (b)(3), (b)(6) LT (b)(3), (b)(6) SSG (b)(3), (b)(6) and myself, was formed to move down to COP Keating for support, Btm 3-61 in defense of the COP. We moved down the mountain in two elements to provide bounding overwatch. We moved along the trail to COP Keating stopping frequently enough that we arrived well after dark. Once we arrived and moved inside the wire (b)(3), (b)(6) moved to the Ashura to link up with my platoon. - End of Statement
