9. I, (b)(3), (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

ON 030ct09, I Woke up to the sound of gunfire. I thought that it was just them doing more harassing fire like normal. Until I really stopped to listen and I knew it was different. I ran over to my NCO's waiting their instruction to run the ammo out to the guard trucks. When the word finally came down for us to go out, I recall SPC. (b)(3), (b)(6) AND SGT. GRIFFEN ran out to what we thought was the E.C.P. that was the last I saw them for awhile. Then at this time myself, Sgt. (b)(3), (b)(6) SGT. (b)(3), (b)(6) AND (b)(3), (b)(6) ran off to the ASP to grab ammo to run to the trucks. We stopped our movement just before the corner going to the ASP. An RPG hit just around the corner from us. At this time me and SPC. (b)(3), (b)(6) layed down fire on the north face and putting green with the 249 SAW and the 240 light weight. We then pushed to the ASP doors which were padlocked. One member of our team shot off the locks. Just as the locks came off another RPG hit next to our location. At this point I looked up to see SGT. (b)(3), (b)(6) stumbling towards me holding his right shoulder. I then looked at his shoulder moving his gear out of the way seeing that he was uninjured we began to head back to the barracks stopping in one of the Afghan buildings to check each other over for injuries. We then ran back to the barracks where we saw that SGT. (b)(3), (b)(6) took some shrapnel to his arm. SSG (b)(3), (b)(6) at this time performed first aid on his wounds. At this time me and a few others were getting ready to head out to attempt to run more ammo again to the trucks. I guess that Sgt. Scusa and SPC. (b)(3), (b)(6) must have left just before us. But as soon as I got to the door I saw SPC. (b)(3), (b)(6) dive through the door first thing I heard was him say

"SCUSA IS SHOT IN THE FACE!" AS WE DRAGGED (b)(3), (b)(6) TO THE BACK WHERE SSG (b)(3), (b)(6) PATCHED UP THE GRAZING WOUND ON HIS LOWER BACK, AND SUITED HIM BACK UP IN HIS GEAR. THEN AT THIS TIME ME AND A FEW OTHERS GATHERED UP SOME SMOKE GRENADES FOR SGT. (b)(3), (b)(6) SO HIM & SGT. (b)(3), (b)(6) COULD CONCEAL THEIR MOVEMENT TO GRAB SGT. SCUSA WHO WAS LYING DEAD NOT EVEN 10m OUTSIDE OUR DOOR. AFTER THEY RETURNED FROM THE AID STATION ME, SFC (b)(3), (b)(6) SGT. (b)(3), (b)(6) SGT. (b)(3), (b)(6) SGT. (b)(3), (b)(6) HEADED BACK TO THE ASP. WHEN WE GOT THERE I GRABBED SOME .50 CAL AMMO AND WAITED FOR SGT. (b)(3), (b)(6) TO GRAB HIS BOXES OF AMMO FOR TRUCK 1. I WAITED FOR HIM BECAUSE HE DIDNT KNOW WHERE THE TRUCK WAS LOCATED SO ONCE I SAW HIM COME OUT I TOOK OFF TOWARDS WHERE THE TRUCK USED TO BE LOCATED. BUT WHEN I WAS RUNNING TOWARDS THAT AREA ALL I SAW UP THERE WAS PFC. (b)(3), (b)(6) AND SGT. HART. I ASKED SGT. HART WHERE THE TRUCK WAS AT. HE TOLD ME THE TRUCK JUST LEFT TO LRAS 2's LOCATION. HE THEN TOLD ME AND (b)(3), (b)(6) TO GO BACK TO THE BARRACKS. SO (b)(3), (b)(6) TOOK OFF AND I FOLLOWED SHORTLY BEHIND AS SGT. HART COVERED OUR MOVE. AS I WAS RUNNING I SAW SGT. (b)(3), (b)(6) RUNNING UP BEHIND ME, I WAVED FOR HIM TO FOLLOW US BACK. THAT WAS THE LAST TIME I SAW SGT. HART I DIDNT REALIZE THIS AT THE TIME. I GOT BACK TO THE BARRACKS SSG (b)(3), (b)(6) TOLD ME TO RELAX FOR A BIT AND DRINK WATER. SHORTLY AFTER WE GOT WORD THAT THE ENEMY WAS IN THE WIRE. I WAS TOLD THAT WE NEED TO SECURE THAT BUILDING I WAS PLACED AT THE BACK DOOR FACING THE NW. WE HAD OTHERS FACING OUR MAIN ENTRANCE OF OUR BARRACKS. SFC (b)(3), (b)(6) WAS AT THE OTHER BACK DOOR FACING THE N. DURING OUR SECURITY ON THIS BUILDING. A RAG CAME THROUGH THAT DOOR, (b)(3), (b)(6) WAS NOT INJURED. THEN SHORTLY AFTER THE FIRE AT THE A.N.A. AREA WAS GETTING CLOSE TO OUR BUILDING. SO WE GRABBED WHAT AMMO WE COULD AND SOME SPARE RADIO BATTERIES WERE STUFFED INTO MY POCKETS BY SGT. (b)(3), (b)(6) THEN A SMOKE WAS THROWN AS WE MOVED FROM OUR BARRACKS TO THE CAFE NEXT TO THE AID STATION. BY THE TIME I GOT TO THE CAFE SFC (b)(3), (b)(6) WAS GRABBING A SNIPER RIFLE FROM THE OMLT F&B SOLDIERS THERE HE SEARCHED FOR THE SNIPER THAT GOT SGT. SCUSA WHEN HE SPOTED HIM (b)(3), (b)(6) TOOK HIM THREE SHOTS TO GET THE GUY. (b)(3), (b)(6) HIM FINALLY BEING OUT OF THE WAY WE SET OUR SECURITY AT THE CAFE. WITH SFC (b)(3), (b)(6) (b)(3), (b)(6) SGT. (b)(3), (b)(6) SGT. (b)(3), (b)(6) AND MYSELF. SFC (b)(3), (b)(6) SGT. (b)(3), (b)(6) SGT. (b)(3), (b)(6) AND (b)(3), (b)(6) WENT TO CLEAR THE NORTHEAST SIDE. I WAS STILL POSITIONED AT THE CAFE. I SAW AT

THIS TIME ONE ENEMY FORCE BY THE MAINTENANCE BAY HOWEVER HE WAS ONLY IN MY VIEW FOR A SECOND BEFORE I HAD A CHANCE TO REACT. I DID HOWEVER SEE OTHERS SHOOTING IN THAT DIRECTION. SHORTLY AFTER SSG (b)(3), (b)(6) CALLED ME OVER TO THE ALLEY AREA BETWEEN THE TALK AND THE RED BARRACKS. HE TOLD ME TO GO WITH THE TWO OMLT FORCES AND SAID THEY WOULD TAKE CARE OF ME. SO I TRUSTED HIM AND TOOK OFF WITH THESE GUYS TO THE DEFAC AREA TO SECURE THAT AREA. ME AND THEM WENT BY THE ENTRANCE OF THE DEFAC FACING THE SWITCHBACKS AND THE DIVING BOARD. AFTER BEING THERE FOR AWHILE SSG (b)(3), (b)(6) TOLD US HE NEEDED HELP GRABBING FIRE EXTINGUISHERS TO OUR BARRACKS. SO ME AND THE OMLT SOLDIERS RAN THOSE TO THE BARRACKS. AFTER THEY WERE GOOD I RAN BACK TO THE SECURITY POSITION. THERE I FOUND THE OMLT GUYS WERE NOT THERE ANYMORE JUST AS I WAS SETTING MYSELF UP TO SECURE THAT POSITION. SFC (b)(3), (b)(6) SFC (b)(3), (b)(6) SFC (b)(3), (b)(6) SHOWED UP WITH ANOTHER 240B WITH AMMO. WE THEN SUPRESSED THE ENEMY AND COVERED A FEW OTHER U.S. SOLDIERS MOVE AS THEY COLLECTED UP OUR U.S. HEROES. I SAT THERE AT THAT POINT FOR THE NEXT FEW HOURS, SGT (b)(3), (b)(6) TOOK PLACE AT OUR POINT. WHEN THE REINFORCEMENTS CAME ME, SGT (b)(3), (b)(6) AND SFC (b)(3), (b)(6) WENT TO WHERE THEY WERE COMING IN WE THEN SPOTTED SGT. HART'S BODY WHERE I LAST SAW HIM. SFC (b)(3), (b)(6) THEN CAME UP TO US WITH A LITER WITH SGT (b)(3), (b)(6) THEN ME, SGT (b)(3), (b)(6) SGT (b)(3), (b)(6) AND SFC (b)(3), (b)(6) WHILE ONE OF OUR REINFORCEMENTS STABILIZED HIS BODY ON THE LITER (b)(3), (b)(6)
