9. I, (b)(3), (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
On the day of Oct 3rd 2009 I was awoken by CPT (b)(3), (b)(6) at aprox 0630 with the message that COP Keating was taking heavy enemy fire. We immediately moved to Fob Bosticks flight line to try and get a ride out to the COP. At approximately 1130 hrs I was told that a QRF was enroute and that I would have to take them on a dismounted patrol from OP Fritsche to COP Keating. The QRF was staged @ OP Fritsche and ready to SP @ aprox 1330. At 39 pax SP @ Fritsche to COP Keating. On the patrol down to the COP, we encountered 2 far ambushes and 1 near ambush. BDA on the near ambush (vic linkup point) was 2 AAF with full rigs, 7.62mm ammo, 2 AK47s, 2 RPGs and aprox 7 RPGs. We collected all of the above materials and continued to COP Keating. At aprox 1800hrs we arrived @ the COP and cleared the Southern half finding 6 enemy KIA. From here we regrouped with the B-TRP element and the QRF set in the outer perimeter. The rest of the unit (B-TRP) was pulled off the line and we (Blue PLT) begin HLZ operations. ->
