I was awakened by gunshots and explosions. As I prepared to respond as part of a qrt team, the order was given to reinforce our rooftop fighting position. I grabbed my m249, and the m240B off my truck, and my teammate spc. [redacted] helped me carry ammo and weaponry to the roof. Once on the roof I began returning fire. I fired about 160 rnds from my saw, when I heard CPT. [redacted] say he was hurt. He said "My leg, My face, I'm hit." I helped lay him down and found the wound on his leg. Then someone said, "I've got him, you go back to shooting" so I did. I heard people yelling for the med ic, but I never saw him. As the firefight began to ~~subside~~ lessen in ferocity, the med ic was still.

I looked over and realized right away who it was, SFC Stone. I placed my hand on the spot, and ~~it~~ recognized it to be a hole. I screamed out his name and, with the help of others around, laid him down from the crouched position he was in. I proceeded to check his ~~heart~~ pulse, and I did not feel one. I checked again, still no pulse. Then someone told me to get back on my weapon, so I did. Everything after that is a blur. I do seem to recall helping put him on the stretcher, but that is all. I just continued to watch for enemy movement.
