I, b(6); b(7)(c)

On the ~~night~~ ^{morning} of 29 MAR 06 the FOB came under attack around 0200. I moved from my room the roof taking a firing position from the NE corner area. The main attack was coming from the NW castle ruins. I immediately started shooting M203 illum. After three (3) illum rounds the rooftop had filled by most of the team. I then switched to my M4 supressing the target area. It was at this point that I heard CPT b(6); b(7)(c) shout that something hit him, as I turned, I saw him standing behind the small wood wall on the roof. As he ~~dro~~ dropped I moved over to render aid. The first injury I found was the large chunk of meaty area missing from his left cheek. As I applied an Israeli bandage another individual help as I then moved to look at his leg, I found an entrance & exit wound on his upper left thigh but figured best to move him ~~of~~ out of the area before dressing the wound. At this point SFC b(6); b(7)(c) noticed a slumped over figure at the top entrance to the stairs, finding out a moment later that it was SFC Stone. I then moved CPT b(6); b(7)(c) down the stairs and around to the CCP. At this point I cut his clothing away and dressed the wound. At the same time SSG b(6); b(7)(c) arrived as the remaining medic and started preping him for medivac. A few moments later one of the SF Medics arrived

and continued in the aid of CPT [b(6); b(7)(c)]. As word of the Air Medical coming in we loaded the Canadian WIA & KIA along with the American WIA & KIA. in the white Ford Ranger. I escorted CPT [b(6); b(7)(c)] to the Blackhawks where we loaded all but one WIA and the KIA's on the first bird. We then found out the second bird would not take any of the KIA's. Later that day we evaced the US & Canadian KIA's out along with the ANA KIA's. Upon my return to the camp from the LZ I went to the roof to assist MAJ [b(6); b(7)(c)] in taking the pictures of where the rounds had been dug out of the wall where CPT [b(6); b(7)(c)] had been standing.
