OUR BASE DEFENSE PLAN FOR ODA 2062 WAS IN THE EVENT OF AN ATTACK WE WERE TO MAN OUR ASSIGNED VEHICLES. THE JTAC AND MYSELF WOULD MAN THE TOWER. POSITIONS ON RIGHT AND LEFT LIMITS WERE MARKED BY CHEMILIGHTS. WE LIVED, WORKED AND OPERATED OVERWATCHING OUR SECTORS OF FIRE. WE ADDITIONALLY OVERWATCHED PATROLS THAT WENT OUT INTO THE DESERT THAT WAY. WE HAVE HAD CDS DROPS AND OBSERVED MORTARS INTO THAT AREA AS WELL. WE ARE VERY FAMILIAR WITH IT. I HAVE STARTED ON A BASE DEFENSE ILLUSTRATION BUT CANNOT FIND AT THIS TIME. THE NIGHT OR MORNING OF THE 28TH OF MARCH WAS A VERY INTENSE, ADRENALINE FILLED EVENT. I CANNOT SAY WITH ANY CERTAINTY WHAT HAPPENED IN THE EVENT IN QUESTION.
