I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
ON THE NIGHT OF 29 MARCH 06 I WAS ASLEEP IN MY MILVAN WHEN I WAS AWAKENED BY AN EXPLOSION & SMALL ARMS FIRE. I WOKE UP MY ROOMMATE AND BEGAN PUTTING ON MY GEAR. HE LEFT AND I FOLLOWED SHORTLY AFTER. I WALKED TO MY ASSIGNED POSITION FOR BASE DEFENSE BECAUSE WE DO NOT RUN INSIDE THE PERIMETER AT NIGHT. AS I REACHED THE VEHICLE, ABOUT 5 MINUTES INTO THE FIGHT FROM THE TIME I WOKE UP A CALL CAME ACROSS THE RADIO FOR A MEDIC FROM OUR CAMP TO MOVE TO THE ETT POSITION IF POSSIBLE BECAUSE POC STONE WAS HIT. I WAS THE ONLY PERSON AT MY POSITION SO FAR SO I REMAINED THERE. I ENTERED THE DRIVERS DOOR & CLIMBED INTO THE TURRET. FROM MY VIEWPOINT I COULD SEE TRACERS & RPG AIR BURSTS TO THE NORTH AND ALOT OF TRACERS COMING UP FROM THE NW NEAR THE CASTLE THEY WERE PASSING ACROSS MY FRONT FROM LEFT TO RIGHT. IT ALSO SEEMED LIKE THERE WERE IMPACTS AGAINST OR NEAR THE HESCO ON THE WEST SIDE OF MY POSITION. I THEN SAW A FLASH & TRACERS FROM MY EAST DOWN IN THE VALLEY. I SPUN THE 290 TO ABOUT MY 3 O'CLOCK & FIRED AT THAT LOCATION. AFTER 3 TO 5 ROUNDS THE GUN JAMMED & I RAISED THE FEED TRAY COVER TO TRY & FIX IT. I THEN FIRED 2 TO 3 ROUNDS AT THAT LOCATION BUT THERE WAS NO MORE TARGETS THERE. [REDACTED] AT ABOUT THAT TIME SFC [REDACTED] ENTERED THE VEHICLE & MOUNTED THE REAR 290. AT THIS TIME I LEFT THE TURRET,

GRABBED MY M5 (MEDIC) BAG & MOVED TOWARDS THE CENTER TELLING b(6); b(7)(c) I WAS GOING TO ETT COMPOUND TO TREAT THEIR CASUALTY(S) I THEN REMEMBERED THAT OUR P.A., b(6); b(7)(c) WAS AT THE AIDE STATION & TALKED WITH INITIAL CASUALTY CARE SO I RETURNED TO THE VEHICLE. & GOT BACK IN THE TURRET. AT ABOUT THIS TIME A GROUP OF CANADIANS CROSSED FROM THE GATE HUGGED ALONG THE WALL TO ALMOST OUR POSITION THEN BEGAN TO MOVE NORTH TOWARDS THE BERM ^{b(7)} ~~PAST~~ THE N. GATE. ^{b(6); b(7)(c)} & I POINTED THEM OUT TO EACH OTHER. AT THAT TIME TRAILERS PASSED NEAR US FROM THE EAST AND ^{b(6); b(7)(c)} BEGAN ENGAGING TO ABOUT OUR 3 O'CLOCK WITH A GOOD RATE OF FIRE. I ^{COMING FROM E.} COULD NOT ENGAGE BUT COULD SEE THE TRAILERS. I CONTINUED TO SCAN W/ MY N.O.D.s AND COULD STILL SEE A HEAVY VOLUME OF FIRE FROM THE WEST & NORTH AS WELL AS ^{HEAR} RPG'S WHISTLING OVERHEAD. AROUND THEN, SOME OF THE CANADIANS RETURNED TO OUR POSITION WITH WOUNDED AND ASKED FOR DIRECTIONS TO THE GATE. THEY BEGAN TO GO THE WRONG WAY & WE REDIRECTED THEM TOWARDS THE GATE. AT THIS TIME 2 MORE PERSONNEL ARRIVED AT OUR POSITION. AND I REPORTED TO ~~THE~~ THE AIDE STATION. WHERE I WAS DIRECTED TO MOVE TO THE ETT COMPOUND

I MOVED OUT ON FOOT, THROUGH OUR GATE, [REDACTED] OVER TO THE ETT COMPOUND AND BEGAN TREATING THEM AND THE ANA CASUALTIES & PREPARING THEM FOR MEDIEVAL. AFTER TREATING AND LOADING THERE 4 CASUALTIES I RETURNED BY FOOT TO THE SF COMPOUND, JUST BEFORE THE HEAVY AIRSTRIKES BEGAN. NOTE: IN ADDITION TO THE CANADIANS TO OUR FRONT THERE WERE [REDACTED] ALSO AN ETT GUN TRUCK TO OUR FRONT (NORTH). AT SOME POINT I SAW SOME TRUCKS FROM THE DIRECTION OF THE ASF COMPOUND BUT I CAN'T TELL HOW FAR OUT BECAUSE THE WALL BLOCKED MY VIEW.
