TERMS AND CONDITIONS

1. PURPOSE: The resale lot is furnished solely for the convenience of personnel for the sale of their personal vehicles. Any use of this area, to further a commercial business enterprise, or to use as storage, is prohibited.

2. LOCATION: There are two authorized lots. Lot #1, located on the main base, is for display of used vehicles for sale: cars, motorcycles, light trucks (1 ton or less), vans, and empty car trailers and is limited to the lined spaces in the parking lot. Lot #2 is located in the marina area and is to be used for the sale of watercraft or trailers, boats, jet skis, campers, recreational vehicles, and larger trucks. All watercraft must be on a trailer. The terms of this agreement is limited to a 30-day period. A vehicle may be registered for an additional 30-day period if space permits. After 60 days the vehicle must be removed for a minimum of 30 days prior to re-registering.

3. ELIGIBILITY:

- A. Only people with a valid DOD I.D. card and vehicles registered in their name (or power of attorney to sell a vehicle for a DOD member).
- B. Only cars, vans, light trucks (1 ton), motorcycles, and empty car trailers may be displayed on lot #1.
- C. Only watercraft on trailers, empty watercraft trailers, campers, RVs, and heavier trucks (over 1 ton) may be displayed on lot #2.
- D. Vehicles to be displayed must be:
 - (1) Properly registered to the owner (POA will be accepted), with current license plate.
 - (2) Insured by the owner. Neither the U.S. Government nor the Services Squadron will be responsible for the loss of and/or damage to your vehicle.
 - (3) Kept clean and in operating condition.

4. PROCEDURES

- A. Bring your vehicle to the Auto Hobby Shop during operating hours.
- B. Complete the resale lot registration form.
- C. Auto Hobby Shop personnel will:
 - (1) Verify valid I.D., vehicle ownership, license plate, and insurance.
 - (2) Collect the established fee for this service. The fee is good for a single vehicle for a period not to exceed 30 days - This Fee is NOT PRORATED nor will Refunds be given after the first day of display.
 - (3) Assign the lot #.
 - (4) Display the red registration sticker in the front windshield of the vehicle.
- D. Take your vehicle to the proper lot and park it in a designated space.
- E. Check your vehicle at least once a week for cleanliness.
- F. Notify Auto Hobby personnel (828-4453) when the vehicle is sold, and have the new owner remove the vehicle on the day of the sale.
- G. If not sold after 30 days, promptly remove your vehicle. You may reapply by following the above procedures, for an additional 30 day period if space permits.

5. ENFORCEMENT:

- A. Security Forces and employees of the Auto Hobby Shop will patrol the lot to enforce compliance with these procedures.
- B. Violators of these policies will be ticketed. If the violation is not corrected within 5 calendar days, the vehicle will be towed at the owner's expense to the base impound lot.

RELEASE OF CLAIMS AND AGREEMENT TO INDEMNIFY

I have read and agree to the terms and conditions above. I hereby release and hold harmless the Auto Hobby Shop, Arts & Crafts Center, 6th Services Squadron, MacDill AFB, the United States Air Force, and any of their officers, employees, or agents from all claims, including claims for loss or damage to my personal property, causes of action, suits, and proceedings, which I, my heirs, or personal representatives may have now or hereafter for any reason pertinent to my displaying my vehicle on the resale lot at MacDill AFB, Florida. I further agree to indemnify any of the persons and organizations named above for any claims or suits against any of them arising in any way from my displaying my vehicle on the Resale Lot.
